Policies Summary:

- **Unlicensed Program Notice:**
This is a recreational afterschool care program and is not licensed by the state. However, all staff members are background-checked and trained. Instruction is provided by certified and licensed teachers who are subject matter experts in their respective fields. Volunteers and Staff in other fields also help,
- **Payment Due:** Tuition is due on the 1st and 15th of each month. Late payments may result in a \$10 late fee. You can pay online or in person by cash, credit card or check.
- **Withdrawal Notice:** Two weeks' notice is required for withdrawal or schedule changes. Please let us know 2 days in advance if your youth will be absent from class unless a sudden illness or emergency occurs.

CHMBT Afterschool Program Opt-In Payment Policy

Purpose

This policy outlines the procedures for enrolling in and making payments for the CHMBT Afterschool Program. By opting into the program, families agree to the terms below regarding participation and payment.

1. Opt-In Requirement

- Participation in the afterschool program is **voluntary** and requires explicit enrollment via the **Opt-In Form**.
 - Parents/guardians must complete and submit the Opt-In Form each academic year (or session) to register their child(ren) in the program.
 - Submission of the form indicates agreement with this payment policy.

2. Program Fees

- Fees are due **weekly/per session** and are based on the selected schedule:
 - **Full-time** (5 days/week): \$90.00, K-12
 - **Full-time** (5 days/week): \$110, Pre-K
 - **Part-time** (3 days/week): \$65
 - **Drop-in rate:** \$25
 - **Hourly rate:** \$7.50
 - **Enrichment Two Week Program** - \$275 – seasonal 2025 (Spring, Winter, Fall)
 - Fees cover supervision, activities, and snacks.

3. Payment Terms

- Payments are due on the **1st and the 15th of the month**
 - Accepted payment methods include credit card, online portal, cash, check, etc.
 - Late payments and late pickup will be a **\$10** charge.
-

4. Refunds & Cancellations

- **No refunds** will be issued for missed days due to illness, vacations, or early pickups.

- If you wish to cancel participation, **written notice** must be submitted at least **10 days** in advance.
 - Refunds for cancellations will be considered on a case-by-case basis.

5. Financial Assistance

- Limited financial aid or fee waivers may be available for families of 5 or more. Contact us for more details.

6. Non-Payment Policy

- If payment is not received 5 days after the due date, your child's enrollment may be **suspended** until the balance is paid in full.
 - Repeated non-payment may result in permanent removal from the program.

CHMBT Afterschool Program Pickup & Drop-Off Policy

Drop-Off:

- Students must be signed in by a parent, guardian, or authorized adult if arriving after school dismissal.
- Drop-off begins at **3pm** for enrichment-only sessions.
- For safety, do not leave your child unattended before program staff are on-site.

Pickup:

- All students must be signed out by a parent, guardian, or an individual listed on the authorized pickup form.
- Pickup is no later than **6:00 PM**
- A **\$10 late fee** will apply for every **10 minutes** after the scheduled pickup time.
- Staff will request photo ID for unfamiliar individuals.

Changes to Pick up:

- Any changes to authorized pickup must be made **in writing** (email or note) and confirmed by staff. A parent may also call.
- We cannot release students to anyone not on the approved list without prior written notice or verbal permission from parent.

STATEMENT OF FAITH
